The County Engineers Association of Maryland is pleased to announce that applications for the 2024 Awards Program are now being accepted. The CEAM Awards Program celebrated another successful year in 2023, with many of our nominated projects going on to receive recognition by the Maryland Quality Initiative, the American Society of Civil Engineers, and the American Council of Engineering Companies. The CEAM Awards will be presented in the following categories:

- The ***Project of the Year Award*** will be presented to the outstanding County Project that demonstrates responsiveness to citizens' needs, cost effectiveness, and innovative use of County staff and funds. Awards will be presented for small (less than \$1,000,000), mid-size (between \$1,000,000 and \$5,000,000), and large projects (greater than \$5,000,000).
- The ***County Engineer of the Year Award*** will be presented to a CEAM County Member for exemplary service to their County and/or the Association.
- The ***Associate Member of the Year Award*** will be presented to a CEAM Associate Member for exemplary service on behalf of Member Counties and/or the Association.
- The ***Meritorious Service Award*** will be presented to a CEAM County or Associate Member for extraordinary service to the Association, service to their County, and/or service to the citizens of Maryland.
- The ***CEAM Service Award*** will be presented to a County Employee for going above and beyond their job description, exhibiting a devotion to public service, and contributing to the advancement of the County's and CEAM's Public Works mission. This person can be any level of County Employee and does not have to be a CEAM member.

Enclosed you will find "Instructions for Submitting Nominations" along with the appropriate forms. This information is also available on the CEAM Website, www.countyengineers-md.org. The deadline for submitting nominations to the Awards Committee is **July 26, 2024**. The 2024 CEAM Awards will be presented at our Fall Conference in Ocean City, September 18–20, 2024.

Instructions for Submitting Nominations for the 2024 CEAM Awards

- County Engineer of the Year – This award shall be presented to a CEAM County Member for exemplary service to their Member County/City in performance of a project or delivery of services, and/or exemplary service to the Association. The recipient shall be a full-time employee of a member County or the City of Baltimore and be a County Member in good standing of the Association. Nominations shall be made by a County Member and seconded by County Member or Associate Member.
- Associate Member of the Year – This award shall be presented to a CEAM Associate Member for contributions to the engineering and construction professions on behalf of Member Counties or the City of Baltimore, and/or exemplary service to the Association. A recipient shall be an Associate Member in good standing of the Association. Nominations may be made by any County Member or Associate Member and seconded by another County Member or Associate Member.
- Meritorious Service Award – This award shall be presented to a CEAM County or Associate Member for extraordinary service to the Association, service to their County, the City of Baltimore, and/or service to the citizens of Maryland. A recipient shall be a member (any CEAM membership grade) in good standing of the Association. Nominations may be made by any County Member or Associate Member and seconded by another County Member or Associate Member.
- CEAM Service Award - This award shall be presented to a County/City Employee who performed outstanding work and for contributing to the advancement of the County's and CEAM's Public Works mission. This award is for all County employee classifications and does not require CEAM Membership. Nominations may be made by a County Member and seconded by any County Member or Associate Member.
- County Project of the Year – This award shall be presented to the outstanding County project considering criteria such as addressing citizens' needs, cost effectiveness, and innovative use of County staff and funds.

Three awards shall be given based on the size of the project, including one for small projects with a construction cost under \$1,000,000, one for mid-sized projects with a construction cost between \$1,000,000 and \$5,000,000, and one for large projects with a construction cost over \$5,000,000. Nominated projects do not need to be constructed projects, such as bridges, roads, water treatment plants, etc., but may be functional projects such as computer system upgrades, management initiatives, or other similar programs. Projects shall be substantially complete by July 26, 2024.

County Project of the Year nominations shall only be made by a Member County and may be seconded by another County Member or Associate Member. A Member County/City may only nominate one (1) project in each category.

Please submit the appropriate form and attachments to the Awards Chair no later than the close of business on **July 26, 2024**. Entries may be submitted in hardcopy and/or digitally. The Awards Committee will verify eligibility, evaluate submissions, and select award recipients.
